# Returns\*

If you purchased an item, you may return it within 14 days, and receive a full refund.

If you return something because: of an error on our part; it's damaged; or it's not described properly, we'll refund the delivery & returning charges.

We do not normally replace or exchange items, due to the limited availability of our stock.

For your protection, we recommend that you use a recorded delivery service for items of more than £10 value.

# 1. Some Important Terms

- You may return any item to ID EDrich within 14 days of delivery and receive a refund.
- If you return a gift purchased for you at ID Edrich you'll receive a gift voucher for the value of your return, which you can use as part or full payment for future purchases from us.
- We do not normally replace or exchange items, due to the limited availability of our stock
- If you return something because of an error on our part or because it's damaged or
  defective, or because it is not described properly, we'll refund the delivery charges
  incurred in sending the item to you and pay your costs of returning it to us,
  providing they are reasonable and provided that they are authorised by us in
  advance.
- We'll check all items returned as damaged, defective or described incorrectly. In the
  event we find no fault, we reserve the right to re-charge you for the item/s and to
  recover our fees and expenses from you.
- By law, customers in the European Union also have the right to withdraw from the purchase of an item within seven working days of the day after the date the item is delivered. This applies to all of our products.
- To cancel your purchase within the seven-working-day cooling-off period, please contact us, giving the reason for the return as "I just don't want it anymore".
- For your protection, we recommend that you use a recorded-delivery service if the value of the return is more than 10GBP.

# 3. Conditions Relating to the Sale of Products to You

This section deals with conditions relating to the sale of products by ID Edrich to you.

#### 3.1. Our contract

When you place an order to purchase a product from ID Edrich, we will send you an e-mail confirming receipt of your order and containing the details of your order. Your order represents an offer to us to purchase a product which is accepted by us when we send e-mail confirmation to you that we've dispatched that product to you (the "Dispatch Confirmation E-mail"). That acceptance will be complete at the time we send the Dispatch Confirmation E-mail to you. Any products on the same order which we have not confirmed in a Dispatch Confirmation E-mail to have been dispatched do not form part of that contract.

#### 3.2. Returns

Please review our Returns Policy, which applies to products purchased from us. In addition to your 30-day returns guarantee, customers in the European Union are entitled to a statutory cooling-off period of seven business days. Details of this statutory right and an explanation of how to exercise it are provided in the order confirmation e-mail and in the Returns Policy.

# 3.3. Pricing and availability

We list availability information for products sold by us on the website. Beyond what we say on that page or otherwise on the website, we cannot be more specific about availability. As we process your order, we will inform you by e-mail if any products you order turn out to be unavailable.

All prices are inclusive of VAT unless stated otherwise.

#### 3.4. Customs

# 4. Privacy Notice

ID Edrich knows that you care how information about you is used and shared and we appreciate your trust in us to do that carefully and sensibly. This notice describes the privacy policy of ID Edrich. By visiting the Website you are accepting and consenting to the practices described in this Privacy Notice.

#### 4.1. Controllers of Personal Information

Any personal information provided to or gathered by ID Edrich is controlled by ID Edrich Partners (the data controllers), all at ID Edrich, 17 Selsdon Road, Wanstead, London, E11 2QF.

# 4.2. What Personal Information About Customers Does ID Edrich Gather?

The information we learn from customers helps us personalise and continually improve your shopping experience at ID Edrich. We use the information to handle orders, deliver products and services, process payments, communicate with you about orders, products, services and promotional offers, update our records and generally maintain your accounts with us, display content such as wish lists and customer reviews and recommend merchandise and services that might be of interest to you. We also use this information to improve our store and platform, prevent or detect fraud or abuses of our website and enable third parties to carry out technical, logistical or other functions on our behalf.

Here are the types of information we gather.

- Information You Give Us: we receive and store any information you enter on our
  website or give us in any other way. You can choose not to provide certain
  information but then you might not be able to take advantage of some of our
  features. We use the information that you provide for such purposes as responding
  to your requests, customizing future shopping for you, improving our store, and
  communicating with you.
- Automatic Information: we receive and store certain types of information whenever you interact with us. For example, like many websites, we use "cookies" and we obtain certain types of information when your Web browser accesses ID Edrich or advertisements and other content served by or on behalf of ID Edrich on other Websites.
- E-mail Communications: to help us make e-mails more useful and interesting, we often receive a confirmation when you open e-mail from ID Edrich if your computer supports such capabilities. .

• Information from Other Sources: we might receive information about you from other sources and add it to our account information.

#### 4.3. What About Cookies?

#### 4.5. How Secure Is Information About Me?

- We reveal only the last four digits of your credit card numbers when confirming an order. Of course, we transmit the entire credit card number to the appropriate credit card company during order processing.
- We maintain physical, electronic and procedural safeguards in connection with the collection, storage and disclosure of personally identifiable customer information.
   Our security procedures mean that we may occasionally request proof of identity before we disclose personal information to you.

We stand behind the promises we make, however, and will never materially change our policies and practices to make them less protective of customer information collected in the past without the consent of affected customers.

#### 4.10. Information You Give Us

You provide most such information when you search, buy, post, participate in a contest or questionnaire or communicate with us. For example, you provide information when you: search for a product; place an order through ID Edrich; provide information in Your Account (and you might have more than one if you have used more than one e-mail address when shopping with us) or your Your Profile; communicate with us by phone, e-mail or otherwise; complete a questionnaire or a contest entry form; compile Wish Lists; and employ other personal notification services. As a result of those actions, you might supply us with such information as: your name; address and phone number; credit card information; people to whom purchases have been dispatched (including addresses and phone numbers); and financial information.

#### 4.11. Automatic Information

Examples of the information we collect and analyse include: the Internet protocol (IP) address used to connect your computer to the Internet; login; e-mail address; password; computer and connection information such as browser type and version; operating system and platform; purchase history, which we sometimes aggregate with similar information from other customers to create features such as Best Sellers; the full Uniform Resource Locators (URL) clickstream to, through and from our website (including date and time); cookie number; products you viewed or searched for; and any phone number used to call our customer service number. We may also use browser data such as cookies, Flash cookies (also known as Flash Local Shared Objects), or similar data on certain parts of our website for fraud prevention and other purposes. # 5. Returns & Refunds Policy

## 5.1. What's ID Edrich's Returns & Refund Policy

You may return any item to ID EDrich within 14 days of delivery and receive a refund.

# 5.2. How can I return something I didn't order myself?

You can pack and return your return in a few simple steps:

- notify ID Edrich of your intention to return the item together with your reason;
- receive a return mailing authorisation from ID Edrich;
- pack the items and return mailing authorisation securely in a box or the parcel used to deliver the item;
- clearly label the box with our address: 17 Selsdon Road, Wanstead, London, E11
   2QF;
- pay the required postage and carriage insurance;
- drop the parcel off at your designated carrier's location.

To make sure you receive the correct refund, please don't include items from other orders or other deliveries in the same box. Every return must have a separate mailing label.

Return delivery costs may be deducted from your refund depending on the reason for return.

# 5.2. How can I return something I didn't order myself?

If you return a gift purchased for you at ID Edrich you'll receive a gift certificate for the value of your return, which you can use as part or full payment for future purchases from us. Don't worry, we won't let the person who sent you the gift know about your return.

Please remember that normal returns criteria apply unless the return is due to an error on our part. If the return isn't due to an error on our part, the refund won't include the cost of gift-wrapping or other services provided in connection with the purchase. The cost of returning the item to us won't be included, unless you're returning shoes that were delivered to an address within the UK.

# 5.3. Return a wrong item

If your package includes an item you weren't expecting or you receive an ID Edrich order and you're not an ID Edrich customer, please contact us.

# 5.4. How can I get something replaced or exchanged?

We do not normally replace or exchange items, due to the limited availability of our stock. If you would like to exchange an item for a different one, please contact us to discuss the matter further. We will not normally exchange items, though we may do so if we feel the situation is exceptional.

# 5.4. Damaged Items

If you receive an item that's damaged, you should contact us to discuss the matter further. If you feel your item was damaged due to poor packaging, please let us know by submitting feedback about the packaging.

#### 5.5. How and when will I be refunded?

Most refunds are issued on the payment method used at the time of purchase. We will endeavour to process your refund quickly and efficiently.

# 5.6. Will any return costs be refunded?

If you return something because of an error on our part or because it's damaged or defective, or because it is not described properly, we'll refund the delivery charges incurred in sending the item to you and pay your costs of returning it to us, providing they are reasonable and provided that they are authorised by us in advance. We'll also refund the cost of gift wrapping and other services provided to you in connection with your purchase, where applicable.

We'll check all items returned as damaged, defective or described incorrectly. In the event we find no fault, we reserve the right to re-charge you for the item/s and to recover our fees and expenses from you.

# 6. Pricing Policy

We try to offer you consistently low prices on our entire catalogue. All prices are listed in GBP. "Our Price", as displayed, is inclusive of UK VAT at the appropriate rate, where relevant.

# 6.1. Confirming Price

Items in your Shopping Basket will always reflect the most recent price displayed on the item's product detail page. Please note that this price may differ from the price shown for the item when you first placed it in your basket. Placing an item in your basket does not reserve the price shown at that time. It is also possible that an item's price may decrease between the time you place it in your basket and the time you purchase it.

We do not charge your credit or debit card until we dispatch your order

# 6.3. What we do about mispricings

Despite our best efforts, a small number of the items in our catalogue are mispriced. Rest assured, however, that we verify prices as part of our dispatch procedures.

If an item's correct price is lower than our stated price, we charge the lower amount and send you the item.

If a product's correct price is higher than our stated price, we will cancel your order and notify you of that cancellation.

# 6.4. Price Matching

We not normally price-match with other retailers. We do, however, consistently work toward maintaining competitive prices on everything we carry. That said, if you think that one of our products is unfairly priced please let us know.

#### 6.5. Bulk Discounts

We do not normally offer additional discounts on large orders of a single title or on large orders of many individual titles.

# 7. Your Statutory Rights

# 7.1. Cooling-off Period

At ID Edrich we want you to be delighted every time you shop with us. Occasionally though, we know you may want to return items. That's why under our 14-day returns guarantee, if for any reason you are unhappy with your purchase, you can return it to us in its original condition within 14 days of the date you received the item.

By law, customers in the European Union also have the right to withdraw from the purchase of an item within seven working days of the day after the date the item is delivered. This applies to all of our products.

To cancel your purchase within the seven-working-day cooling-off period, please contact us, giving the reason for the return as "I just don't want it anymore". Please package the relevant item securely and send it to us as stated within our Returns & Refunds Policy.

For your protection, we recommend that you use a recorded-delivery service if the value of the return is more than 10GBP.

Please note that you will be responsible for the costs of returning the items to us unless we delivered the item to you in error, or if the item is damaged or defective. If we do not receive the item back from you with the delivery slip, we may arrange for collection of the item from your residence at your cost.

You should be aware that once we begin the delivery process you will not be able to cancel any contract you have with us for additional services carried out by us (eg: giftwrapping).

As soon as we receive notice of your cancellation of this order, we will refund the relevant part of the purchase price for that item together with the item's normal postage charge. We cannot refund any priority, express or courier component of the postage charge.
